In a series of open market transactions through the Canadian Securities Exchange and private sales (collectively, the “**Transactions**”), the Company sold 2,811,000 Common Shares of Metalla at an average price of C\$1.09 per share between April 25, 2019, and September 24, 2019 for approximately C\$3.1 million in total proceeds.

Prior to the first transaction on April 25, 2019, Coeur owned 23,776,241 Common Shares of Metalla, or approximately 19.9% of its issued and outstanding Common Shares. Following the Transactions, Coeur now owns 20,965,241 Common Shares of Metalla, or approximately 15.9% of its issued and outstanding Common Shares.
