In October 2018, Mackenzie’s managed accounts purchased 1,928,700 Shares of Pason, crossing above the 12.5% threshold.

Mackenzie's previous report dated October 10, 2018, reported holdings of 8,879,523 Shares representing approximately 10.394% of total shares outstanding on behalf of Mackenzie managed accounts as at September 30, 2018. Since October 1, 2018 the aggregate number of Shares held by Mackenzie's managed accounts has increased by 1,928,700 Shares. As a result of the acquisition of Shares, Mackenzie's security holding percentage has increased by approximately 2.258%.

Mackenzie reports that the number of Shares of Pason held by Mackenzie's managed accounts as at October 31, 2018 was 10,808,523 Shares, representing approximately 12.652% of the total Shares outstanding.
