On November 23, 2021, a total of 2,000,000 Warrants with an exercise price of \$0.15 per common share of the Corporation (“**Share**”) held by 2176423 Ontario (a corporation beneficially owned by Eric Sprott) expired unexercised, resulting in (i) Mr. Sprott’s beneficial ownership of the Corporation to decrease by approximately 7.3% on a partially diluted basis since the date of the last early warning report and (ii) Mr. Sprott’s beneficial ownership position to decrease to below 10% on a partially diluted basis.

The 2,000,000 Warrants that expired represent a decrease in holdings of approximately 7.3% of the Shares outstanding on a partially diluted basis assuming the Warrants had been exercised and a beneficial ownership position of less than 10% since Mr. Sprott's previously filed early warning report.

Prior to the expiry of these Warrants, Mr. Sprott beneficially owned and controlled 4,722,500 Shares and 2,000,000 Warrants representing approximately 5.2% of the outstanding Shares on a non-diluted basis and approximately 7.2% on a partially diluted basis assuming the exercise of such Warrants.

Mr. Sprott now beneficially owns and controls 4,722,500 Shares, representing approximately 5.2% of the outstanding Shares on a non-diluted basis.

The Warrants expired unexercised and out of the money. Mr. Sprott has a long-term view of the investment and may acquire additional securities including on the open market or through private acquisitions or sell the securities including on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Sprott currently has no other plans or intentions that relate to or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
