On February 28, 2022, the Issuer completed a private placement offering (the “Offering”) of units (the “Units”) sold at a price of \$0.065 per Unit, each Unit comprised of one common share in the capital of the Issuer and one common share purchase warrant (a “Warrant”) entitling the holder to acquire one common share at a per share price of \$0.085 (subject to adjustment in certain events) until February 28, 2027.

Upon completion of the Offering, the securityholding percentage of the acquiror’s beneficial ownership of, and/or control or direction over, common shares in the capital of the Issuer on a post-conversion partially diluted beneficial ownership basis, decreased to 14.57%.

See Item 2.2 above. The Offering by the Issuer and the associated dilution that triggered the requirement to file this report decreased the acquiror's securityholding percentage of common shares on a post-conversion partially diluted basis by approximately 3.63%.

The Offering and associated dilution triggered the requirement to file this report. See Item 2.2 and 3.1 above.
