On August 21, 2024, the Issuer completed a private placement offering (the “Offering”) of common shares sold at a price of \$0.05 per common share.

The acquiror has acquired ownership over an aggregate 5,290,000 common shares of the Issuer, issued by the Issuer from its treasury, under the Offering.

2.3 *State the names of any joint actors.*

Navdeep Dhaliwal (“Dhaliwal”) and NLX Capital Corp., together with the acquiror are hereinafter referred to as the “NLX Group”.

The participation in the Offering by the acquiror and a previous grant of stock options to Dhaliwal that together triggered the requirement to file this report increased the NLX Group's securityholding percentage of the Issuer's share capital on a post-conversion beneficial ownership basis by approximately 2.37%.

3.2 State whether the acquiror acquired or disposed ownership of, or acquired or ceased to have control over, the securities that triggered the requirement to file the report.

The acquiror acquired ownership over the securities that triggered the requirement to file this report. See Item 2.2 and 3.1 above.

Immediately before the acquiror's participation in the Offering, the NLX Group held 17,500,446 common shares of the Issuer representing approximately 17.98% of the Issuer's then issued and outstanding common shares and owned and/or exercised control or direction over stock options and warrants entitling the purchase of an aggregate 4,607,692 common shares in the capital of the Issuer; or assuming exercise of the stock options and the warrants, a total of 22,108,138 common shares of the Issuer or approximately 21.68% on a post-conversion beneficial ownership basis.

Immediately after the acquiror's participation in the Offering, the NLX Group held 22,790,446 common shares of the Issuer representing approximately 19.98% of the Issuer's then issued and outstanding common shares and owned and/or exercised control or direction over stock options and warrants entitling the purchase of an aggregate 4,607,692 common shares in the capital of the Issuer; or assuming exercise of the stock options and the warrants, a total of 27,398,138 common shares of the Issuer or approximately 23.08% on a post-conversion beneficial ownership basis.

The NLX Group owns and/or exercises direction or control over the securities indicated in Item 3.4.

The aggregate 5,290,000 common shares acquired pursuant to the Offering that are the subject of this report were acquired at a per common share price of \$0.05, for total cash consideration of \$264,500.

The aggregate 5,290,000 common shares that are the subject of this report were acquired pursuant to the Offering conducted by the Issuer. See Item 4.1 above for the nature and value of the consideration in this regard.

The NLX Group will evaluate its investment in the Issuer and will increase or decrease the investments by future acquisitions or dispositions of securities of the Issuer at its discretion, as circumstances warrant. As of the date of this report and except as otherwise disclosed in this report, the NLX Group has no immediate future intention

to acquire additional securities of the Issuer, but may dispose some of the securities of the Issuer that it owns or over which it exercises control or direction.

The NLX Group may, in the future and at its discretion, exercise stock options and/or warrants that it owns and, thus, acquire additional common shares in the capital of the Issuer.

As of the date of this report, the NLX Group is not aware of any plans nor has any future intentions that would relate to or result in any of items (b) through (k) of Item 5 above.
