On August 22, 2022 the Acquiror disposed of 300,000 Common Shares of the Issuer at \$0.03 per Common Share in a private transaction.

On August 23, the Acquiror disposed of 5,950,000 Common Shares of the Issuer) at \$0.03 per Common Share through the facilities of Nasdaq Canada Exchange.

On August 24, the Acquiror disposed of 6,000,000 Common Shares of the Issuer at \$0.03 per Common Share on the market through the facilities of Nasdaq Canada Exchange.
