The transaction giving rise to this report was closing of a private placement of units of the Issuer ("**Units**") on August 14, 2019. Each Unit consists of one Common Share and one transferable common share purchase warrant ("**Warrant**"), with each Warrant entitling the holder thereof to purchase one additional Common Share at a price of \$0.05 per share until August 14, 2021.

On August 14, 2019, the Acquiror acquired control of 1,000,000 Units, consisting of 1,000,000 Common Shares (representing 5.03% of the issued and outstanding Common Shares) and 1,000,000 Warrants. The Units were acquired by the Acquiror pursuant to the terms of a subscription agreement.

See item 2.2. The Acquiror acquired control of 1,000,000 Units, consisting of 1,000,000 Common Shares and 1,000,000 Warrants.

The Acquiror acquired control over the 1,000,000 Units, consisting of 1,000,000 Common Shares and 1,000,000 Warrants.

Prior to the acquisition of the 1,000,000 Common Shares and 1,000,000 Warrants, the Acquiror held 492,832 Common Shares, or approximately 4.98% of the total issued and outstanding Common Shares, and 416,667 common share purchase warrants, exercisable at \$0.20 per share until July 26, 2020 (the "2016 Warrants").

The Acquiror now controls 1,492,832 Common Shares, or approximately 7.50% of the total issued and outstanding Common Shares, 416,667 2016 Warrants and 1,000,000 Warrants. Assuming the exercise of the 2016 Warrants and the Warrants, the Acquiror would own or control 2,909,499, or approximately 13.65% of the total issued and outstanding Common Shares.
