The transaction giving rise to this report was closing of a private placement of units of the Issuer (“**Units**”) on November 26, 2020. Each Unit consists of one Common Share and one transferable common share purchase warrant (“**Warrant**”), with each Warrant entitling the holder thereof to purchase one additional Common Share at a price of \$0.05 per share until November 26, 2022.

**Item 2 - Identity of the Acquiror**

On November 26, 2020, the Acquiror acquired control of 1,000,000 Units, consisting of 1,000,000 Common Shares (representing 2.34% of the issued and outstanding Common Shares) and 1,000,000 Warrants. The Units were acquired by the Acquiror pursuant to the terms of a subscription agreement.

See item 2.2. The Acquiror acquired control of 1,000,000 Units, consisting of 1,000,000 Common Shares and 1,000,000 Warrants.

The Acquiror acquired control over the 1,000,000 Units, consisting of 1,000,000 Common Shares and 1,000,000 Warrants.

Prior to the acquisition of the 1,000,000 Common Shares and 1,000,000 Warrants, the Acquiror held 2,628,062 Common Shares, or approximately 13.21% of the total issued and outstanding Common Shares, and 2,000,000 common share purchase warrants.

The Acquiror now controls 3,628,062 Common Shares, or approximately 8.51% of the total issued and outstanding Common Shares, 2,000,000 common share purchase warrants and 1,000,000 Warrants. Assuming the exercise of the common share purchase warrants and the Warrants, the Acquiror would own or control 6,628,062, or approximately 13.45% of the total issued and outstanding Common Shares.

Increase or decrease in ownership of securities of the Issuer will depend on numerous conditions, including the price of the Common Shares and general market conditions.
