On June 17, 2021, the Acquiror acquired 7,900,000 units (“Units”) at a price of C\$0.28 per Unit in connection with the public offering of up to C\$6 million in the aggregate Units by the Issuer (the “Issuance”). Each Unit is comprised of one common share of the Issuer (a “Common Share”) and one-half common share purchase warrant (each whole purchase warrant, a “Warrant”). Each Warrant

entitles the holder to acquire one Common Share at an exercise price of C\$0.40 for a period of two years from date of issue.
