

The following discussion and analysis of the operations, results and financial position of WestKam Gold Corp. (the "Company") for the year ended October 31, 2021 should be read in conjunction with the October 31, 2021 audited year-end financial statements and the notes thereto, which can be found on SEDAR at www.sedar.com.

This Management Discussion and Analysis ("MD&A") is dated March 1, 2022 and discloses specified information up to that date. The Company is classified as a "venture issuer" for the purposes of National Instrument 51-102. The Company's financial statements are prepared in accordance with International Financial Reporting Standards ("IFRS") in Canada. Unless otherwise cited, references to dollar amounts are in Canadian dollars.

The Company is a reporting issuer in each of the provinces of British Columbia and Alberta. Its head office and registered office is located at Suite 900 – 570 Granville Street, Vancouver, BC, V6C 3P1.

We recommend that readers consult the "Cautionary Statement" on the last page of this report.

Description of Business

The Company was incorporated in British Columbia under the Company Act of British Columbia on October 2, 1984 as Consolidated Goldwin Ventures Inc. and effectively on April 30, 2012 changed its name to WestKam Gold Corp. The Company's strategy is to identify, acquire, explore and develop precious and base metal deposits amenable to low production costs and high operating margins, focusing on properties with low initial entry costs.

Overall Performance and Outlook

The Company is currently focusing its exploration efforts on the Bonaparte property located in British Columbia, Canada. During the fiscal year ended October 31, 2021, the Company did not undertake any significant exploration work programs as access to the property was prohibited because of Provincial orders restricting travel and access due to wildfires in the region from July to mid-September 2021. The Company was able to undertake complete water monitoring and other geological assessment and planning outside of that time frame. The Company is currently planning work on the property in the summer of 2022. The Company will also continue to evaluate similar opportunities for base and precious metals projects, focusing on projects in North America.

The outbreak of the coronavirus, also known as "COVID-19", has spread across the globe and is impacting worldwide economic activity. Conditions surrounding the coronavirus continue to rapidly evolve and government authorities have implemented emergency measures to mitigate the spread of the virus. The outbreak and the related mitigation measures may have an adverse impact on global economic conditions as well as on the Company's business activities. The extent to which the coronavirus may impact the Company's business activities will depend on future developments, such as geographic spread of the disease, the duration of the outbreak, travel restrictions, business disruptions, and the effectiveness of actions taken in Canada to contain and treat the disease. These events are highly uncertain and as such, the Company cannot determine their financial impact at this time.

Company Activity

The Company has been on care and maintenance as a result of the COVID-19 pandemic and has completed certain corporate actions during this time. Management was unable to complete exploration activity on its property due to government restriction orders placed as a result of wildfires in the Spark Lake area of British Columbia from July to mid-September 2021. The area under restriction encompasses a large area and included all Bonaparte claims. The Company will focus its efforts on a spring/summer 2022 exploration program on its Bonaparte property.

Year ended October 31, 2021

On November 11, 2020, the Company completed a non-brokered private placement, issuing 8,125,331 units at a price of \$0.12 per unit for total proceeds of \$975,040, of which \$285,000 had been received in fiscal 2020 and recorded as share subscriptions. Each unit consisted of one common share and one common share purchase warrant exercisable at \$0.20 per share for a period of two years. No value was attributed to the warrant portion of the units. The Company paid a total of \$7,753 and issued a total of 65,940 warrants as finder's fees with a fair value of \$14,079. The Company incurred other share issue costs of \$33,164, of which \$11,381 was recorded as deferred financing costs at October 31, 2020.

Bonaparte Gold Property – Kamloops, British Columbia

In fiscal 2011, the Company acquired a 75% interest in the Bonaparte Gold property located in the Kamloops mining district in British Columbia.

To acquire its 75% interest, the Company paid \$8,001,550, issued 3,250,000 common shares with a value of \$4,750,000, and incurred certain expenditures on the property.

On January 24, 2012 the Company acquired a 100% right to a portion of land adjacent to the Bonaparte property. The rights were received in exchange for settlement of prepaid exploration costs of \$501,627.

In fiscal 2014, the Company entered an option agreement to acquire an additional 17% interest on its existing claims of the Bonaparte Gold property for consideration of 6,500,000 common shares (issued at a value of \$350,000) and payment of \$150,000 in cash (paid).

Additionally, the Company acquired the remaining 8% interest in the Bonaparte Gold property through the issuance of 10,950,000 common shares valued at \$547,500, bringing the Company's interest in the Property to 100% of all claims.

As at October 31, 2021, the Company has issued reclamation bonds of \$100,000 (2020 - \$100,000) for future reclamation work on the Bonaparte Gold property.

During fiscal 2021, the Company has recognized a reclamation obligation of \$41,000 (2020 - \$41,000). The undiscounted amount of estimated cash flows was estimated at \$41,000. The liability was estimated using an expected life of two years and a discount rate of 1.5 %.

Year ended October 31, 2021

During the year ended October 31, 2021, the Company completed a private placement, issuing 8,125,331 units at a price of \$0.12 per unit for total proceeds of \$975,040.

Year ended October 31, 2020

During the year ended October 31, 2020, the Company completed a debt settlement transaction, issuing 7,208,560 common shares at a value of \$1,117,327 to retire \$720,856 of amounts payable to consultants, lenders and other creditors, including insiders, resulting in a loss on settlement of \$396,471.

Results of Operations

This review of the Results of Operations should be read in conjunction with the financial statements of the Company for the years ended October 31, 2021 and 2020.

Twelve months ended October 31, 2021 compared with the twelve months ended October 31, 2020

Expenses

General and administrative expenses totaled \$403,712 for the year ended October 31, 2021 compared with \$337,032 in 2020. Details of the largest changes and significant general and administrative items are as follows:

- Consulting expenses increased by \$46,600 to \$111,600 from \$65,000. The increase is due to the engagement of an administrative consultant and payment of director's fees.
- Professional fees increased by \$9,921 to \$29,818 from \$19,897. This is attributable mostly to audit and tax fees.
- Investor relations and shareholder information decreased by \$13,214 to \$5,820 from \$19,034 and is due mainly to the termination of market making services.
- Management fees increased by \$5,000 to \$175,000 from \$170,000, due primarily to unpaid leave taken by a corporate officer having been taken in fiscal 2020.
- Office expenses decreased significantly by \$22,647 to \$3,566 from \$26,213 and is due primarily to a reduction in rent and elimination of other costs associated with shared premises.

- Regulatory and filing fees increased by \$3,674 to \$37,080 from \$33,406 and is attributable to increases in filing fees associated with transaction submissions pursuant to a private placement transaction completed during the year.

The Company recorded \$2,000 in interest expense and penalties during the year ended October 31, 2021 compared with \$162,076 in 2020, a decrease of \$160,076 resulting from interest paid on notes payable repaid and amounts accrued for penalties and interest.

The Company did not record any losses relating to settlement of debt as compared to \$396,471 recorded during the year ended October 31, 2020.

Additionally, the Company did not record any impairment of receivables deemed to be uncollectible as compared to \$25,629 recorded during the year ended October 31, 2020.

The Company recorded no mineral property impairment losses during fiscal 2021 as compared to \$14,340,198 recorded in the year ended October 31, 2020 on its Bonaparte property .

Exploration Expenses

The Company incurred \$40,170 in net exploration expenses during the year ended October 31, 2021 compared with \$2,668 in 2020, an increase of \$37,502.

Three months ended October 31, 2021 compared with the three months ended October 31, 2020

Expenses

General and administrative expenses totaled \$135,527 for the three months ended October 31, 2021 compared with \$38,063 in 2020. Details of the largest changes and significant general and administrative items are as follows:

- Consulting expenses increased by \$21,500 to \$36,500 from \$15,000 as a result of the engagement of an administrative consultant and payment of director's fees.
- Professional fees increased by \$12,057 to \$25,525 from \$13,468, and are attributable to accrued audit fees recorded for the fiscal 2021 audit.
- Investor relations and shareholder information decreased by \$12,843 to \$(1,938) from \$10,905 as a result of shareholder information expenses recovered during the quarter.
- Management fees increased by \$10,000 to \$45,000 from \$35,000.
- Regulatory and filing fees increased by \$7,076 to \$12,951 from \$5,875 and is attributable to an increase in costs associated with regulatory filing fees.

The Company recorded interest expense and penalties of \$2,000 during the quarter ended October 31, 2021 compared to \$140,536 in the same quarter 2020, a result of additional interest.

The Company did not record any losses relating to settlement of debt as compared to \$396,471 recorded during the year ended October 31, 2020.

Additionally, the Company did not record any impairment of receivables deemed to be uncollectible as compared to \$25,629 recorded during the year ended October 31, 2020.

The Company recorded no mineral property impairment losses during fiscal 2021 as compared to \$14,340,198 recorded in the year ended October 31, 2020 on its Bonaparte property .

Exploration Expenses

The Company incurred exploration and evaluation expenditures of \$17,265 for the three months' ended October 31, 2021 compared to \$6,303 in 2020.

Liquidity

At October 31, 2021, the Company had current assets of \$154,946, of which \$130,853 was comprised of cash. Current liabilities totaled \$609,112, all of which consisted of trade payables.

Total working capital as at October 31, 2021 was (\$454,166). The Company continues to assess funding opportunities to address its ongoing financial obligations and for exploration programs on its property and will pursue debt or equity financings to address its working capital requirements.

Capital Resources

The Company plans to continue its participation in the Bonaparte project discussed above. The Company expects to finance expenditures on these projects through the sale of common shares by way of equity financings, and through the exercise of warrants and stock options.

Off-Balance Sheet Arrangements

The Company has no off-balance sheet arrangements.

Related Party Transactions

Amounts owing to related parties consists of \$216,746 (2020 - \$446,777).

Related Party Transactions – Key Management Compensation

During the year, \$120,000 (2020 - \$120,000) was paid or accrued to a company controlled by the President and CEO, Matt Wayrynen, for services as director and officer of the Company, \$40,000 was paid or accrued to a director of the company, Corey Klassen (2020 - \$nil) and \$55,000 (2020 - \$50,000) was paid or accrued to the CFO, Pamela Saulnier, for services as an officer of the Company.

Financial Instruments and Risk Management

Fair values

Fair value estimates of financial instruments are made at a specific point in time, based on relevant information about financial markets and specific financial instruments. As these estimates are subjective in nature, involving uncertainties and matters of significant judgment, they cannot be determined with precision. Changes in assumptions can significantly affect estimated fair values. The Company classifies the fair value of the financial instruments according to the following hierarchy based on the amount of observable inputs used to value the instrument:

- Level 1 - inputs to the valuation methodology are quoted prices for identical assets or liabilities in active markets;
- Level 2 - inputs to the valuation methodology included quoted prices for identical assets or liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument. Level 2 valuations are based on inputs, including quoted forward prices for commodities, time value and volatility factors, which can be substantially observed or corroborated in the marketplace; and,
- Level 3 - inputs to the valuation methodology are not based on observable market data, and approximate fair value due to their short term nature.

The fair value of cash is measured at Level 1 of the fair value hierarchy. The carrying value of receivables, reclamation bonds, and accounts payable and accrued liabilities are measured at amortized cost using effective interest rate.

Financial instrument risk exposure and risk management

The Board of Directors has overall responsibility for the establishment and oversight of the Company's risk management framework. The Company considers the fluctuations of financial markets and seeks to minimize potential adverse effects on financial performance.

The Company is exposed in varying degrees to a variety of financial instrument related risks. The Board approves and monitors the risk management process.

Credit risk

Credit risk is the risk of a financial loss to the Company if a counterparty to a financial instrument fails to meet its contractual obligation. The Company's exposure to credit risk includes cash and receivables. The Company reduces its credit risk by maintaining its bank accounts at large international financial institutions. The Company's receivables consist primarily of grants due from federal government agencies. The maximum exposure to credit risk is equal to the fair value or carrying value of the financial assets.

Liquidity risk

Liquidity risk is the risk that the Company will not be able to meet its obligations as they become due. The Company's ability to continue as a going concern is dependent on management's ability to raise required funding through future equity issuances. The Company manages its liquidity risk by forecasting cash flows from operations and anticipating any investing and financing activities. Management and the Board of Directors are actively involved in the review, planning and approval of significant expenditures and commitments. Interest rate risk

The Company has cash balances. The Company's current policy is to invest excess cash in investment grade short-term demand deposit certificates issued by its banking institutions. The company periodically monitors the investments it makes and is satisfied with the credit rating of its banks. The Company is marginally exposed to interest rate risk. The Company's bank account earns interest income at variable rates. The fair value of its portfolio is relatively unaffected by changes in short-term interest rates.

Foreign currency risk

The Company has limited exposure to foreign currency risk on currency fluctuations related to monetary items with a settlement currency other than Canadian dollars.

Commodity price risk

The Company is exposed to price risk with respect to commodity and equity prices. Equity price risk is defined as the potential adverse impact on the Company's earnings due to movements in individual equity prices or general movements in the level of the stock market. Commodity price risk is defined as the potential adverse impact on earnings and economic value due to commodity price movements and volatilities. The Company closely monitors commodity prices of gold and other precious and base metals, individual equity movements, and the stock market to determine the appropriate course of action to be taken by the Company.
