On August 28, 2023, Generic acquired (the "**Acquisition**") 2,600,000 Units of the Company at a price of \$0.05 per Unit. Each Unit is comprised of one common share (each, a "**Common Share**") in the capital of the Company and one Common Share purchase warrant (each, a "**Warrant**"). Each Warrant entitles the holder thereof to purchase one Common Share at a price of \$0.10 for a period of twenty-four (24) months from the date of issuance. Generic subscribed for the Units in connection with a non-brokered private placement of the Issuer.

Pursuant to the Acquisition, Generic received 2,600,000 Units. Prior to the completion of the Acquisition, Generic held 10,427,500 Common Shares, representing approximately 15.89% of the issued and outstanding Common Shares on a non-diluted and partially diluted basis. Upon completion of the Acquisition, Generic holds 13,027,500 Common Shares and 2,600,000 Warrants, representing approximately 17.15% of the Company's issued and outstanding Common Shares on a non-diluted and approximately 19.90% on a partially diluted basis.
