Christopher Anderson Acquires Units in Ximen Mining Corp.

VANCOUVER, BC, April 24, 2017 – Christopher Anderson acquired 2,500,000 units (the “**Units**”) of Ximen Mining Corp. (TSXV:XIM) (the “**Issuer**”) at a price of \$0.055 per Unit. The Units are comprised of 2,500,000 common shares and 2,500,000 share purchase warrants of the Issuer (the “**Warrants**”), exercisable at \$0.075 per share for a period of five years. These securities were acquired by Mr. Anderson for investment purposes only. Mr. Anderson may acquire additional securities of the Issuer in the future.

Mr. Anderson now holds beneficial ownership, direction or control over, an aggregate of 9,658,642 common shares, 3,801,542 share purchase warrants (including the Warrants), and 1,375,000 incentive share purchase options, representing in aggregate approximately 12.86% of the outstanding common shares of the Issuer on a non-diluted basis, and 18.48% on a partially-diluted basis.
