**2.2 State the date of the transaction or other occurrence that triggered the requirement to file this report and briefly describe the transaction or other occurrence.**

On May 17, 2021, the Acquiror acquired 1,655,000 units of the Issuer (the “**Units**”) at \$2.29 per Unit pursuant to a private placement of units (the “**Private Placement**”). Each Unit is comprised of one common share in the capital of the Issuer (each, a “**Share**”) and one Share purchase warrant (each, a “**Warrant**”). Each Warrant is exercisable into an additional Share (each, a “**Warrant Share**”) at \$2.75 per Warrant Share for a period of three years from the date of issuance, provided however if at any time the closing price of the Issuer’s Shares listed is equal to or greater than \$10.00 per Share for a period of 15 consecutive trading days, the Issuer may accelerate the expiry date of the Warrants by giving notice to the holders thereof and in such case the Warrants will expire on the 30<sup>th</sup> business day after the date on which such notice is given by the Issuer.

Immediately prior to purchasing the Units, the Acquiror held 1,500,000 Shares representing 35.33% of the then issued and outstanding Shares.

Immediately after purchasing the Units, the Acquiror held 3,155,000 Shares and 1,655,000 Warrants, representing 43.36% of the issued and outstanding Shares on a partially-diluted basis.

As a result of the Acquiror’s participation in the Private Placement, the Acquiror’s securityholding percentage increased by 8.03% on a partially-diluted basis.

**3.2 State whether the acquiror acquired or disposed ownership of, or acquired or ceased to have control over, the securities that triggered the requirement to file this report.**

The Acquiror acquired 1,655,000 Shares and 1,655,000 Warrants, which triggered the requirement to file this report.

Immediately after purchasing the Units, the Acquiror held 3,155,000 Shares and 1,655,000 Warrants, representing 43.36% of the issued and outstanding Shares on a partially-diluted basis.

The Acquiror beneficially owns and exercises control or direction over 3,155,000 (33.43% of the Issuer's issued and outstanding Shares on an undiluted basis). Assuming full exercise of the Warrants, the Acquiror would beneficially own or otherwise exercise control or direction over 4,810,000 Shares (43.36% on a partially diluted basis).
