On December 23, 2025, the Acquiror acquired a total of 60,000,000 shares of the Issuer. Immediately before the transaction, the Acquiror held 310,000 shares or convertible securities of the Issuer.

Prior to the Acquisition, the Acquiror had beneficial ownership and control over 310,000 securities of the Issuer, representing 0.18% of the issued and outstanding shares of the Issuer on an undiluted basis. The Acquiror acquired beneficial ownership and control of a total of 60,000,000 shares of the capital of Issuer, which shares represents 18.48% of the Issuer’s 324,691,368 issued and outstanding shares. As a result, the Acquiror now has beneficial ownership of 60,310,000 shares, approximately 18.57% of the issued and outstanding shares of the Issuer.

The Acquiror acquired the beneficial ownership of shares of the Issuer.
