On May 8, 2024, Fern Macdonald acquired 18,000 common voting shares (the “**Acquisition**”) bringing her total holdings in the Issuer to 16.3% of the issued and outstanding Common Shares of the Issuer (on a non-diluted basis).

This report is being filed as the purchase increased Ms. Macdonald’s holdings by >2% of the issued and outstanding securities of the Issuer.

Ms. Macdonald acquired 18,000 common voting shares of the Issuer bringing Ms. Macdonald’s holdings from 14.06% to 16.3% of the Issuer’s outstanding Common Shares (on a non-diluted basis), and the Acquisition increased Ms. Macdonald’s holdings of the Issuer, in aggregate by >2% of the issued and outstanding securities of the Issuer, since the last early warning report that she filed.

Ms. Macdonald acquired the securities that triggered the requirement to file this report.
