This report relates to the acquisition of common shares of Prosper Gold Corp. (the “**Issuer**”) pursuant to a private placement that closed on November 29, 2018.

Stichting Depository Plethora Precious Metals Fund (the “**Acquiror**”) acquired under a private placement beneficial ownership of, or control or direction over, common shares, which together with its current holdings of Issuer’s securities, constitutes 10% or more of the Issuer’s common shares (“**Shares**”) issued and outstanding on a partially diluted basis.

On November 29, 2018, the Acquiror acquired a total of 2,500,000 Units (herein defined) at \$0.10 for gross proceeds of \$250,000. Each “**Unit**” consists

of one Share and one common share purchase warrant in the Issuer (a “**Warrant**”). Each whole Warrant is exercisable into a Share at a price of \$0.15 expiring on November 29, 2020. In total, the Acquiror acquired 2,500,000 Shares and 2,500,000 Warrants under the Private Placement (the “**Acquisition**”).

As a result of the Acquisition, Acquiror beneficially owns, or exercises control or direction over more than 10% of the Issuer’s issued and outstanding Shares.

The Acquiror had ownership or direction and control over an aggregate of 5,470,000 Shares prior to the Acquisition, representing approximately 9.58% of the issued and outstanding Shares on a partially diluted basis. On an undiluted basis, the Acquiror owned 3,100,000 common shares, representing 5.66% of the issued and outstanding Shares.

Following the Acquisition, the Acquiror has ownership or direction or control over 10,470,000 Shares representing approximately 16.87% of the issued and outstanding Shares on a partially diluted basis. On an undiluted basis, the Acquiror now has ownership or direction or control over 5,600,000 Shares, representing 9.8% of the issued and outstanding Shares.

The Acquiror acquired ownership, control or direction over 5,000,000 Shares pursuant to its Acquisition.

The Acquiror paid \$250,000 for the Units acquired on November 29, 2018 under the Issuer's private placement.
