On May 25, 2018, the Corporation announced the completion of its previously announced "Change of Business" ("**COB Transaction**") pursuant to the policies of the TSX Venture Exchange (the "**Exchange**"), with the result that the Corporation became a blockchain technology Corporation listed on the Exchange. In connection with the COB Transaction, the Corporation changed its name to "BlockchainK2 Corp." (the "**Name Change**"). Trading of the Corporation's shares on the Exchange resumed under its new stock symbol "BITK" on May 31, 2018.
