The 1,666,667 Units were acquired on June 23, 2023. Each Unit is comprised of one common share and one-half of one common share purchase warrant. Each Warrant is exercisable to acquire one common share of the Issuer at an exercise price of C\$0.40 per share until December 23, 2024.

Immediately following the transaction that triggered the requirement to file this news release, Dundee and its affiliates owned or controlled an aggregate of 3,253,967 common shares and 833,333 warrants, representing an approximate 12.63% interest in the Issuer on an undiluted basis and a 15.37% interest in the Issuer on a partially diluted basis.
