Immediately following the transaction that triggered the requirement to file this report, Dundee and its affiliates own or control an aggregate of 4,708,520 common shares and 833,333 warrants, representing an approximate 9.58% interest in the Issuer on an undiluted basis and a 11.09% interest in the Issuer on a partially diluted basis.
