Acquisition of Securities of Global Daily Fantasy Sports Inc.

Mr. Darcy Krogh announces that on August 17, 2018, in connection with a financing completed by Global Daily Fantasy Sports Inc. ("Global Daily"), he acquired control or direction over 670,000 units of Global Daily at a price of \$0.15 per unit. Each unit comprised one common share and one-half of one share purchase warrant. Each whole warrant entitles the holder to purchase an additional common share of the Company at a price of \$0.40 for a period of three years from the date of issuance.

Prior to the above acquisition Mr. Krogh had control or direction over 5,796,397 common shares and the right to acquire 678,750 common shares of Global Daily through the exercise of Global Daily options and Global Daily warrants representing approximately 11.72%. Assuming exercise of the options and warrants, Mr. Krogh would acquire control over 6,475,147 common shares of Global Daily, representing approximately 12.92% of the then outstanding common shares of Global Daily, calculated on a partially diluted basis assuming the full exercise of his options and warrants.

Immediately after the acquisition of the 670,000 Global Daily units, Mr. Krogh has control over 6,466,397 common shares of Global Daily representing 11.62% of the outstanding common shares of Global Daily, and the right to acquire 1,013,750 common shares through the exercise of Global Daily options and Global Daily warrants. In the event that these options and warrants are exercised, Mr. Krogh would acquire control over a maximum of 7,480,147 common shares of Global Daily. These combined holdings would represent approximately 13.20% of the outstanding common shares of Global Daily, calculated on a partially diluted basis assuming the full exercise of the Global Daily options and warrants held by Mr. Krogh.

Mr. Krogh acquired the Global Daily shares for investment purposes only and not with a view to materially affect control of Global Daily. Mr. Krogh is the President, CEO and a director of Global Daily.

In the future, Mr. Krogh may take such actions in respect of his holdings in Global Daily as he may deem appropriate, depending on the then market conditions and circumstances.
