On May 17, 2023, a total of 3,950,000 Warrants with an exercise price of \$0.30 per common share of the Corporation (“**Share**”) expired unexercised, resulting in Mr. Sprott’s beneficial ownership of the Corporation to decrease by approximately 5.0% on a partially diluted basis since the date of the last early warning report.

The 3,950,000 Warrants that expired represent a decrease in holdings of approximately 5.0% of the Shares outstanding on a partially diluted basis from what was reported in the last early warning report. See items 2.2 and 3.4.

Prior to the expiry of these Warrants, Mr. Sprott beneficially owned 7,900,000 Shares and 3,950,000 Warrants representing approximately 11.8% of the outstanding Shares on a non-diluted basis and 16.7% on a partially-diluted basis assuming the exercise of such Warrants.

Mr. Sprott now beneficially owns 7,900,000 Shares representing approximately 11.8% of the outstanding Shares on a non-diluted basis.

The Warrants expired unexercised. Mr. Sprott has a long-term view of the investment and may acquire additional securities including on the open market or through private acquisitions or sell the securities including on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Sprott currently has no other plans or intentions that relate to or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
