On September 30, 2019, a total of 12,500,000 Warrants with an exercise price of \$0.12 per common share of the Corporation (“**Share**”) held by 2176423 Ontario (a corporation beneficially owned by Mr. Sprott) expired, resulting in Mr. Sprott’s beneficial ownership of the Corporation to decrease by approximately 11.1% on a partially diluted basis since the previously filed early warning report.

The 12,500,000 Warrants that expired represent, since the previously filed early warning report, a decrease in holdings of approximately 11.1% of the Shares outstanding on a partially diluted basis assuming the Warrants had been exercised.

Prior to the expiry of Warrants, Mr. Sprott beneficially owned and controlled 12,500,000 Shares and 12,500,000 Warrants, representing approximately 13.7% of the outstanding Shares on a non-diluted basis and approximately 24.2% on a partially diluted basis assuming exercise of the Warrants.

Mr. Sprott now beneficially owns and controls 12,500,000 Shares representing approximately 13.7% of the outstanding Shares on a non-diluted basis.

The Warrants expired unexercised and out of the money. Mr. Sprott has a long-term view of the investment and may acquire additional securities either on the open market or through private acquisitions or sell securities either on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Sprott currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
