On October 16, 2024 (the "**Acquisition Date**"), Belantis acquired ownership of 4,100,000 Common Shares (the "**Purchased Shares**").

The Purchased Shares were acquired in connection with the Offering at \$0.03 per Common Share for an aggregate amount equal to C\$123,000.

After the Offering, Belantis owns, or has control or direction over, 14,800,000 Common Shares and 2,000,000 Options, representing approximately 14.53% of the issued and outstanding Common Shares on a partially diluted basis.
