On August 27, 2025 (the "**Acquisition Date**"), Belantis acquired indirect ownership of 5,758,571 Common Shares and 5,758,571 Warrants (the "**Purchased Securities**"). Each Warrant entitles the holder thereof to acquire one additional Common Share at an exercise price of C\$0.065 for a period of two years from the date of issuance thereof, subject to the option of the Issuer to accelerate the expiry date in the event that its shares trade at \$0.10 for ten consecutive trading days.

The Purchased Securities were acquired in connection with the Offering at \$0.035 per Common Share for an aggregate amount equal to C\$201,550.

Prior to the Offering, Belantis owned, or had control or direction over 14,800,000 Common Shares, and 2,000,000 options to purchase Common Shares ("**Options**") and 6,000,000 Warrants, representing approximately 18.4% of issued and outstanding Common Shares on a partially diluted basis. After the closing of the Offering, Belantis owns, or has control over 20,558,571 Common Shares, 2,000,000 Options, and 11,758,571 Warrants representing approximately 20.6% of the issued and outstanding Common Shares on a partially diluted basis.
