This report is filed in respect of the acquisition of common shares of the Issuer (the “**Shares**”) pursuant to a private placement of the Issuer on the TSX Venture Exchange (the “**Transaction**”).

The acquiror is Evandra Nakano (the “**Acquiror**”). The Acquiror is an individual with an address at Suite 515 – 701 W. Georgia St., Vancouver, British Columbia, V7Y 1C6.

On September 5, 2025, the Acquiror acquired ownership of 700,000 Shares of the Issuer at \$0.03 per Share pursuant to a non-brokered private placement financing (the “**Financing**”).

The Acquiror acquired 700,000 Shares, representing 1.43% of the Issuer’s currently issued and outstanding Shares. Following acquisition of the 700,000 Shares, the Acquiror has ownership of 6,076,250 Shares of the Issuer, representing approximately 12.48% of the issued and outstanding Shares of the Issuer.

The Acquiror acquired ownership and control of the securities that are the subject of this report.

Following completion of the Transaction, the Acquiror acquired ownership of 700,000 Shares of the Issuer, representing 1.43% of the issued and outstanding Shares of the Issuer.

Following completion of the Transaction, the Acquiror has ownership of 6,076,250 Shares, and 1,300,000 stock options, of the Issuer, representing approximately 12.48% of the issued and outstanding Shares of the Issuer (or 7,376,250 Shares or 14.75% of the issued and outstanding Shares of the Issuer on a partially diluted basis assuming the exercise of all options held by the Acquiror).
