During September 2020, Crescat had net dispositions of 26,788 common shares of the Issuer (“**Common Shares**”). In addition, the Issuer’s issued and outstanding share capital increased. As a result of the foregoing, Crescat’s holdings in the Issuer have fallen below 10%.

Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

In September, Crescat had net dispositions of 26,788 Common Shares. As at September 30, 2020, Crescat held approximately 9.82% of the total number of issued and outstanding Common Shares; as at August 31, 2020, Crescat held approximately 21.81% of the total number of issued and outstanding Common Shares. Assuming that Crescat exercises in full the 10,000,000 share purchase warrants of the Issuer (“**Warrants**”) it holds, Crescat will hold 20,759,853 Common Shares representing approximately 17.37% of the outstanding Common Shares on a partially diluted basis.

As at September 30, 2020, Crescat exercised control over 10,759,853 Common Shares, representing approximately 9.82% of the outstanding Common Shares, and Warrants to purchase 10,000,000 Common Shares. Assuming that the Warrants are exercised in full, Crescat will hold 20,759,853 Common Shares representing approximately 17.37% of the outstanding Common Shares on a partially diluted basis.
