On May 10, 2020, 3,077,000 Warrants with an exercise price of \$0.18 per common share of the Corporation (“Share”) held by 2176423 Ontario (a corporation beneficially owned by Mr. Sprott) expired unexercised.

The 3,077,00 Warrants that expired represent, since the filing of the most recent early warning report and subsequent Shares issuances by the Corporation, a decrease in holdings of approximately 7.3% of the Shares outstanding from what was previously reported in such early warning report.

Prior to the expiry of the 3,077,000 Warrants, Mr. Sprott beneficially owned and controlled 3,077,000 Shares and 3,077,000 Warrants, representing approximately 6.2% of the outstanding Shares on a non-diluted basis and approximately 11.7% on a partially diluted basis assuming the exercise of these Warrants.

Mr. Sprott now beneficially owns and controls 3,077,000 common shares representing approximately 6.2% of the outstanding common shares on a non-diluted basis.

The Warrants expired unexercised and out of the money.. Mr. Sprott has a long-term view of his investment and may acquire additional securities including on the open market or through private acquisitions or sell the securities including on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Sprott currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporations' business and financial conditions and/or other relevant factors, M. Sprott may develop such plans or intentions in the future.
