As a result of net sales of common shares of the Issuer (“**Common Shares**”) by Crescat in November 2021, Crescat’s holdings in the Issuer have fallen below 17.50%.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

The aggregate number of Common Shares held and the number of Common Shares that may be acquired by Crescat pursuant to the exercise of Warrants has decreased by 1,599,809 Common Shares. In addition, there has been an increase in the Issuer’s issued and outstanding share capital. In total, the percentage of Common Shares held or that may be acquired by Crescat has decreased by approximately 1.90%.

As at November 30, 2021, Crescat exercised control over 12,160,450 Common Shares, representing approximately 9.69% of the outstanding Common Shares, and 10,000,000 common share purchase warrants of the Issuer (“**Warrants**”). Assuming that the Warrants are exercised, Crescat will hold 22,160,450 Common Shares representing approximately 16.36% of the issued Common Shares on a partially diluted basis as at November 30, 2021.

Assuming the Warrants are exercised, Crescat will exercise ownership and control over an aggregate of 22,160,450 Common Shares representing approximately 16.36% of the outstanding Common Shares on a partially diluted basis as at November 30, 2021.
