As a result of net purchases of common shares of the Issuer (“**Common Shares**”) acquired by Crescat in July 2021, Crescat’s holdings in the Issuer have risen above 17.50%.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

Assuming that the Warrants are exercised, Crescat will hold 22,896,772 Common Shares representing approximately 17.60% of the issued Common Shares on a partially diluted basis as at July 31, 2021.
