On August 25, 2025, the Acquiror acquired 500,000 Units at a price of \$0.11 in a private placement for a total investment of \$55,000. Each Unit is comprised of one common share and one common share purchase warrant. Each warrant entitles the holder to acquire one common shares of the Issuer for a period of two years from the closing of the private placement at an exercise price of \$0.15 per share.
