On December 22, 2020, the acquiror acquired beneficial ownership and control of 1,000,000 units with each unit consisting of one common share and one half of one common share purchase warrant with each warrant entitling the holder to purchase one common share for a period of 24 months at \$0.20 per share.

The acquiror held 2,975,000 common shares prior to the acquisition that triggered the requirement to file this report. The acquiror acquired an additional 1,000,000 common shares, resulting in ownership and control over a total of 3,975,000 common shares, which represents approximately 12.46% of the total issued and outstanding Common Shares of the Issuer as at December 22, 2020.

If the Acquiror exercises all the warrants acquired under this transaction, it would beneficially own 4,475,000 common shares of the Issuer, which would represent approximately 13.81% of the issued and outstanding common shares of the Issuer on a fully diluted basis.

The acquiror acquired a total of 1,000,000 common shares that triggered the requirement to file this report.
