On September 10, 2019, Mason acquired ownership of 1,400,000 units (the “**Units**”) of the Issuer at a price of \$0.05 per Unit pursuant to a private placement transaction. Each Unit consists of one common share of the Issuer (a “**Share**”) and one share purchase warrant, with each warrant being exercisable into one additional Share, at a price of \$0.10 per Share until September 10, 2021.

3. Interest in Securities of the Reporting Issuer

On September 10, 2019, Mason acquired ownership of 1,400,000 Units of the Issuer, resulting in Mason acquiring an additional 1,400,000 Shares, or approximately 5.79% of the Issuer's Shares. Upon the acquisition of the Units, the number of Shares held by Mason increased to 2,667,370 Shares, representing approximately 11.04% of the Issuer's issued and outstanding Shares.

3.2 *State whether the acquiror acquired or disposed ownership of, or acquired or ceased to have control over, the securities that triggered the requirement to file the report.*

Mason acquired ownership and control over the securities that triggered the requirement to file this report.

Immediately prior to the transaction that triggered the requirement to file this report, Mason had beneficial ownership and control of an aggregate of 1,267,370 Shares, representing approximately 5.72% of the issued and outstanding Shares on a non-diluted basis. Prior to the transaction, Mason also held 600,000 share purchase warrants for the purchase of an additional 600,000 Shares and 314,750 stock options for the purchase of an additional 314,750 Shares. Assuming the exercise of the share purchase warrants and stock options in full, Mason would have held 2,182,120 Shares or approximately 9.45% of the Issuer's Shares.

Immediately after the transaction giving rise to the requirement to file this report, Mason had beneficial ownership and control of an aggregate of 2,667,370 Shares, representing approximately 11.04% of the issued and outstanding Shares on a non-diluted basis. Mason now holds 2,000,000 share purchase warrants for the purchase of an additional 2,000,000 Shares and 314,750 stock options for the purchase of an additional 314,750 Shares. Assuming the exercise of the stock options and share purchase warrants in full, Mason would own a total of 4,982,120 Shares, representing approximately 18.81% of the issued and outstanding Shares, assuming no other Shares are issued.

Mason alone has ownership and control over 2,667,370 Shares representing approximately 11.04% of the issued and outstanding Shares. See item 3.4 above.
