On October 23, 2018 Wolverton, through his wholly-owned company, acquired ownership of 41,000 common shares of the Issuer (the “**Shares**”) at a price of \$0.26 per Share.

On October 23, 2018, Wolverton, through his wholly-owned company, acquired ownership of 41,000 Shares of the Issuer, or approximately 0.57% of the Issuer's issued and outstanding Shares. Upon the acquisition of these Shares, the number of Shares beneficially owned by Wolverton increased from 1,173,000 Shares, representing approximately 16.17%, to 1,214,000 Shares, representing approximately 16.74% of the Issuer's issued and outstanding Shares.

Wolverton acquired ownership and control over the securities that triggered the requirement to file this report.
