VANTEX ANNOUNCES CORPORATE UPDATE

Vancouver, BC, July 10, 2023 – Vantex Resources Ltd. (the “Company” or “Vantex”) (TSX-V: VAX) announces a corporate update regarding the Company’s halted status. The trading of Vantex Resources Ltd. shares was originally halted on March 22, 2023, pending the Company’s response to inquiries about its deficiency in holding an annual general meeting and the Company’s outdated contact information.

Following a meeting of shareholders held on May 23, 2023, the exchange made attempts to contact the Company to address their questions. Unfortunately, due to outdated information on the Company’s SEDAR profile, the exchange was unable to contact the Company through normal procedures but has since established contact with the Company within the past couple of months.

Since the original halt being four and a half months ago, Vantex has taken immediate action to rectify this situation by updating its information, responding to any further questions from the exchange, holding the annual general meeting of shareholders, and submitting various outstanding filings with the exchange to remove any deficiencies. The Company has diligently worked towards resolving the issues in order to remove the halt on trading and restore normal operations.

Vantex is committed to transparency and compliance with regulatory requirements. The Company acknowledges the importance of maintaining accurate and up-to-date information and will continue to prioritize prompt communication with regulatory bodies and shareholders.
