*This report relates to common shares ("**Common Shares**") of African Metals Corporation. (the "**Issuer**"). The Issuer's head office is located at 1600-925 West Georgia Street, Vancouver, BC, V6C3L2.*

*The Issuer completed a private placement of 4,000,000 common shares (the "**Shares**"), as disclosed in its news release dated May 21, 2021 (the "Private Placement"). The Common Shares trade on the NEX Board of the TSX Venture Exchange ("**TSXV**") under the trading symbol "**AFR.H**".*

*The acquiror is Simeon Tshisangama (the "**Acquiror**"). The Acquiror's address is 34 AV de la liberation, Lubumbashi, Democratic Republic of Congo.*

- 2.2 State the date of the transaction or other occurrence that triggered the requirement to file this report and briefly describe the transaction or other occurrence.

The Issuer completed the Private Placement on May 17, 2021, in escrow, subject to final approval by the TSXV. Final approval by the TSXV was given on May 25, 2021.

In aggregate, the Acquiror acquired 1,230,000 Common Shares pursuant to the Private Placement of the Issuer.

The Acquiror 1,230,000 Common Shares of the Reporting Issuer in the Private Placement.

The Acquiror after the Private Placement, beneficially owns, control or have direction over, directly or indirectly, 3,457,923 Common Shares representing 19.2% of the issued and outstanding Common Shares.

The Acquiror acquired the Common Shares.

Prior to the Private Placement, Simeon Tshisangama, together with TSM Entreprise Sarl ("TSM"), owned 2,227,923 Common Shares of the Issuer, representing approximately 15.8% of the then outstanding Common Shares of the Issuer (14,038,681).

After completion of the Private Placement, Simeon Tshisangama, together with TSM, owned 3,457,923 Common Shares of the Issuer, representing approximately 19.2% of the then outstanding Common Chares of the Issuer (18,038,681), an increase of greater than 2% since his last Early Warning Report.
