On December 5, 2017, the Acquiror purchased 616,000 shares (the “**Shares**”) in ordinary course transactions through the facilities of the TSXV at prices of \$0.04 as to 366,000 shares and \$0.045 as to 250,000 shares.

616,000 Shares were purchased by the Acquiror on December 5, 2017. The Acquiror’s securityholding percentage in the Shares was changed from 4.13% to approximately 5.64%. Assuming exercise of the 2,441,500 share purchase warrants (the “**Warrants**”) of the Issuer held by the Acquiror, the Acquiror’s holdings changed from 9.7% to 11.19%.

The Acquiror acquired ownership of 616,000 Shares.

The Acquiror held 1,634,500 shares of the Issuer prior to the transaction (4.13% of the outstanding shares of the Issuer) and the Acquiror held 2,250,500 shares after the transaction (5.64% of the outstanding shares of the Issuer). Assuming exercise of the 2,441,500 Warrants held by the Acquiror, the Acquiror's holdings went from 9.7% to 11.19%
