On December 7, 2020, the Acquiror acquired beneficial ownership and control over 5,114,062 Common Shares pursuant to a Qualifying Transaction on the TSX Venture Exchange involving the Issuer and Canadian Teleradiology Services, Inc. Further information can be found in the Filing Statement of the Issuer dated November 26, 2020 posted on www.sedar.com.

Immediately prior to completion of the Qualifying Transaction, the Acquiror did not have ownership of, or exercised control or direction over, any voting or equity securities of the Issuer.
