On August 5, 2020, 2176423 Ontario acquired (the “**Acquisition**”) ownership of 11,904,761 Units of the Corporation at a price of \$0.42 per Unit. Each Warrant comprising part of a Unit entitles the holder thereof to acquire one Share at a price of \$0.60 per Share until two years after the issuance of the Warrant. The Units were purchased from the Corporation on a private placement basis. 2176423 Ontario is beneficially owned by Eric Sprott.

The Acquisition results in Mr. Sprott's beneficial ownership of the Corporation to increase by approximately 5.1% of the outstanding Shares on a partially diluted basis from what was reported in the most recent early warning report.

Mr. Sprott acquired beneficial ownership of the Units. See item 2.2.

Prior to the Acquisition, Mr. Sprott beneficially owned and controlled 36,666,666 Shares and 36,666,666 Warrants, representing approximately 12.2% of the issued and outstanding Shares on a non-diluted basis, and approximately 21.8% on a partially diluted basis assuming exercise of the Warrants.

After giving effect to the Acquisition, Mr. Sprott beneficially owns and controls 48,571,427 Shares and 48,571,427 Warrants, representing approximately 15.6% of the issued and outstanding Shares on a non-diluted basis, and approximately 26.9% on a partially diluted basis assuming exercise of the Warrants.

The Units were acquired for investment purposes. Mr. Sprott has a long-term view of the investment and may acquire additional securities including on the open market or through private acquisitions or sell the securities including on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Sprott currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.

Item 6 – Agreements, Arrangements, Commitments or Understandings With Respect to Securities of the Reporting Issuer

The closing of the private placement was disclosed by the Corporation in a press release on August 6, 2020. 2176423 Ontario entered into a subscription agreement to acquire the Units. Mr. Sprott has undertaken that, unless approval of disinterested shareholders of the Corporation has been,

obtained and any other requirements of the TSX Venture Exchange (“TSXV”) have been satisfied, the Warrants will only be exercised by 2176423 Ontario to the extent that Shares issued upon such exercise would not result in him becoming a “control person” (as such term is defined in the policies of the TSXV) of the Corporation.
