## THUNDERSTRUCK CLOSES OVERSUBSCRIBED PRIVATE PLACEMENT

November 9, 2018 – Vancouver, British Columbia – Thunderstruck Resources Ltd. (“Thunderstruck”; TSX-V: AWE) announces that, further to its press release dated November 5, 2018, it has closed its previously announced private placement (the “Placement”) of \$100,000.

Gross proceeds of \$114,220 were raised through the sale of 1,903,667 units at a price of \$0.06 per unit (each a “Unit”). Each Unit comprised one common share and one half of one share purchase warrant. Each whole warrant entitles the holder to purchase a further common share at a price of \$0.15 per share until November 9, 2021. The warrants are subject to accelerated exercise provisions such that if the closing price of the Company’s common shares exceeds \$0.25 per share for a period of 20 consecutive trading days, the Company may give notice of the acceleration of the warrants’ term to a period of 30 days following such notice.

Bryce Bradley, President/CEO stated “We will be presenting at the London Mines and Money November 26-29 and look forward to advancing discussions with potential partners to continue developing our highly prospective suite of zinc, copper and gold assets.”

No finder’s fees were payable in connection with the Placement.

All securities issued are subject to a hold period in Canada expiring on March 10, 2019. Additional restrictions may apply pursuant to Rule 144 of the Securities Act of 1933, as amended, to U.S. investors.

Proceeds of the Placement will be applied to exploration programs for the Company’s Fiji properties and general working capital.

Thunderstruck Resources is a Canadian mineral exploration company that has assembled extensive and highly prospective properties in Fiji on which recent and previous exploration has confirmed VMS, copper and precious metals mineralization. The Company provides investors with exposure to a diverse portfolio of exploration stage projects with potential for zinc, copper, gold and silver in a politically safe and stable jurisdiction.
