On October 22, 2025, Torex acquired all of the issued and outstanding Prime Shares in exchange for each shareholder of Prime receiving 0.060 of a common share of Torex (each whole share, a “**Torex Share**”) for each Prime Share held, pursuant to a plan of arrangement under the *Business Corporations Act* (British Columbia) (the “**Arrangement**”).

Pursuant to the Arrangement, Torex acquired 168,023,004 Prime Shares, representing 100% of the issued and outstanding Prime Shares. Prior to the completion of the Arrangement, Torex held no Prime Shares.

Torex directly acquired the Prime Shares pursuant to the Arrangement.

Immediately prior to the completion of the Arrangement, Torex did not own any Prime Shares. Immediately following the completion of the Arrangement, Torex owns 168,023,004 Prime Shares, representing 100% of the issued and outstanding Prime Shares.

Pursuant to the terms of the Arrangement, each holder of Prime Shares received 0.060 of a Torex Share for each Prime Share held as of the effective time of the Arrangement.

The purpose of the Arrangement was for Torex to acquire all of the issued and outstanding Prime Shares in order for Prime to become a wholly-owned subsidiary of Torex.
