On June 15, 2018 Columbus Gold disposed of 1,650,000 Common Shares of the Issuer at \$0.35 per share.

Columbus Gold disposed of 1,650,000 Common Shares representing 3.5% of the issued and outstanding Common Shares of the Issuer. As a result Columbus Gold continues to hold 3,533,496 Common Shares of the Issuer (less than 10%).

Columbus Gold disposed of 1,650,000 Common Shares of the Issuer.
