On November 18, 2024, Mark Trevelyan Smethurst, a director of the Corporation acquired indirectly 6,400,000 Shares of the Corporation (the “**Securities Acquired**”) following the share acquisition of the Corporation by 14697952 Canada Inc. (formerly Canadian Gold Resources Ltd.) which constituted a “Reverse Takeover” transaction in accordance with TSX Venture Exchange Policy 5.2 – *Changes of Business and Reverse Takeovers*.

Mr. Smethurst currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Smethurst may develop such plans or intentions in the future.
