On December 9, 2020, Mr. Sprott donated 3,321,893 Shares to The Sprott Foundation (which is controlled by Mr. Sprott).

After the 3,321,893 Shares were donated to The Sprott Foundation, and due to previous treasury share issuances by the Corporation, there is a decrease in beneficial ownership and control of Shares to less than 10% of the outstanding Shares (and a decrease of approximately 4.7% from what was reported in the last early warning report). See items 2.2 and 3.4.

Sprott disposed of beneficial ownership of, but retained control over, the 3,321,893 Shares.

After the donation, Mr. Sprott still controls 20,713,199 Shares which represent approximately 7.5% of the outstanding Shares on a non-diluted basis.

Mr. Sprott has a long-term view of the investment and may acquire additional securities including on the open market or through private acquisitions or sell securities including on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Sprott currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
