The Acquiror acquired 900 Common Shares on June 1, 2020 pursuant to a purchase on the TSX Venture Exchange (the "**Acquisition**").

The Acquiror became an insider of the Issuer on January 26, 2014. The Acquiror subsequently acquired and disposed of securities of the Issuer, on the public market, privately and through the conversion or exchange of securities, resulting in the Acquiror holding 237,679 Common Shares immediately prior to the Acquisition representing approximately 19.56% of the Issuer's outstanding Common Shares.

The Acquiror acquired 900 Common Shares, resulting in an increase of 0.07% from 19.56% to 19.63% in the Acquiror's securityholding percentage of Common Shares issued and outstanding.
