The report relates to units (“Units”) in the capital of Fokus Mining Corporation (the “Issuer”). Each Unit consists of one common share issued as a “flow-through share” under the *Income Tax Act* (Canada) and one-half of a common share purchase warrant. The Issuer’s head office is located at 147 Québec Avenue, Rouyn-Noranda, QC J9X 6M8.

PearTree Securities Inc. (“PT”) as restricted portfolio manager to a flow-through limited partnership (the “Fund”). PT’s head office is located at 400-110 Eglinton Avenue West, Toronto, ON, Canada M4R 1A3.

On October 16, 2020, PT on behalf of the Fund acquired an aggregate of 7,475,000 Units at \$0.40 per Unit (the “Purchased Units”) in a private placement of the Issuer (the “Offering”). On October 16, 2020 PT disposed, on behalf of the Fund, of all the Purchased Units.

PT is an eligible institutional investor pursuant to Section 1.1(1) of National Instrument 62-103 - *The Early Warning System and Related Take-Over Bid and Insider Reporting Issues* (“NI 62-103”), and is eligible to file reports under Part 4 of NI 62-103 in respect of the Issuer.

Upon completion of the Offering, the shares comprising the Purchased Units acquired by PT, on behalf of the Fund, represented 15.65% of the issued and outstanding Common Shares on a partially diluted basis, and 17.62% on a fully diluted basis. Following the disposition reported herein, PT does not have direction or control over any Units.
