Hammer is an Australian company (ACN 095 092 158) engaged in the exploration and extraction of mineral resources in Australia.

On June 27, 2019, Hammer acquired 19,255,641 common shares in the capital of the Issuer as consideration in accordance with the terms of a Share Sale Agreement dated November 27, 2018, among the Issuer, Hammer and its subsidiaries, pursuant to which the Issuer acquired certain resource project interests.

Hammer acquired 19,255,641 common shares in the capital of the Issuer representing approximately 19.9% of the Issuer’s issued and outstanding common shares, as a result of which Hammer’s securityholding percentage of the Issuer’s common shares increased by 19.9%.
