The Option was granted to Mr. Wilson on February 10, 2023.

Mr. Wilson previously owned 2,000,000 Common Shares and now owns 2,000,000 Common Shares, representing 11.76% of the issued and outstanding Common Shares, and the Option to acquire 212,500 Common Shares. Assuming the exercise of the entire Option held by Mr. Wilson, he will own 2,212,500 Common Shares, representing 12.85% of the issued and outstanding Common Shares.
