As announced on November 15, 2017, pursuant to a private agreement, Africa Oil acquired a 19.77% shareholding in Eco through the purchase of 29,200,000 common shares at CAD\$0.48 per share, for a total consideration of CAD\$14,016,000 (approximately US\$10.9 million).
