On September 10, 2020, the Acquiror acquired 22,000,000 units (“Units”) at a price of C\$0.15 per Unit in connection with the public offering of up to 65,914,707 in the aggregate Units by the Issuer (the “Issuance”). Each Unit is comprised of one common share of the Issuer (a “Common Share”) and one-half of one common share purchase warrant (each, a “Warrant”). Each whole Warrant entitles the holder to acquire one Common Share at an exercise price of C\$0.20 until September

10, 2023.
