**Change to the TSX Ticker Symbol of Global X Pipelines & Energy Services Index ETF**

As announced on April 18, 2024, effective May 1, 2024, the TSX ticker symbol of Global X Pipelines & Energy Services Index ETF (formerly, Horizons Pipelines & Energy Services Index ETF) will change from HOG to PPLN.

**Change to the Name of the Manager**

As announced on March 6, 2024, effective May 1, 2024, the name of the Manager, Investment Manager and Trustee of the ETFs has been changed from Horizons ETFs Management (Canada) Inc. to Global X Investments Canada Inc.

**PURCHASERS' STATUTORY RIGHTS OF WITHDRAWAL AND RESCISSION**

Securities legislation in certain of the provinces and territories of Canada provides purchasers with the right to withdraw from an agreement to purchase ETF securities within 48 hours after the receipt of a confirmation of a purchase of such securities.
